SOTH Bible Day Camp – Policies and Procedures

Applications

Applications will be accepted on a first-come, first-served basis, according to age. There is an attendance cap on each grade level. Should your application be received following the maximum capacity for applicable grade, it will be held on a wait-list, if you so elect.

Registration Fee

A \$ 35 (per family) registration fee is due with submission of application. Placement cannot be guaranteed without the registration fee.

Weekly Fee

The weekly fee – per camper – is \$ 85.00. Fees are required to be paid at the beginning of each week and are considered late by close of camp on Mondays. Late fees are \$5.00 per day. Sorry, no family rates or partial weeks.

Attendance

Hours of camp operation: 7:00 a.m. until 6:00 p.m. Late fees will occur at the rate of \$1.00 per minute, unless prior arrangements are made. **Initial: _____** When camper is absent for three consecutive days, without notification to camp director, place will be considered vacated and could be filled from wait-list.

Discipline

Discipline will be handled in accordance with most public school classrooms. Expectations and consequences will be stated clearly and posted within view of every child and parent. Serious infractions with regard to repeated uncooperative behavior, safety of camper, or danger to others, will be grounds for immediate removal from program.

Camper's Responsibility

Bring refillable water-bottle, clearly marked with name. Bring bag lunch and simple snack every day, unless special fun-days are posted. DO NOT bring soda or candy. Water will be supplied during lunch and snack. **Camper's must wear sunscreen daily** – please apply prior to arrival at camp. On water days, campers are to bring swimsuit, towel and change of clothes, as needed. Campers must wear protective shoes AT ALL TIMES. Flip-flops or water shoes are acceptable on water days.

Electronics Free Camp

There will be lots of fun and challenging activities every day. **Please do not bring electronic items of any kind to camp.** If camper must bring a cell phone, it will be held by camp staff, in a secure location during camp. SOTH Bible Day Camp will not be responsible for lost or stolen items. **Initial: _____**
